By law change proposed – It was proposed to make the following change to the by laws in the event that we add the use of the wireless system in our league. The vote on this will be taken in March.

Original Wording – Three timers will time each lane with the middle time being the official time. (Then add new wording) If using a wireless timing system there will be two timers per lane and the average of the two times shall be the official time. The hosting team shall ensure that there will be enough manual back-up stop watches available in case the wireless system fails.

A, B, C Divisions – The Division assignments were announced.
